THE CENTER PRIMARILY BENEFITS LOW-INCOME FAMILIES WHO NEED CHILDCARE BECAUSE THEY ARE EMPLOYED, IN SCHOOL OR IN TRAINING. SOME FAMILIES PAY THE FEE FOR SERVICE THROUGH THEIR CHILDCARE SUBSIDIES, WHILE OTHERS PAY ACCORDING TO A SLIDING SCALE FEE STRUCTURE. THE CENTER IS A HEAD START AND EARLY HEAD START PROGRAM PROVIDER THROUGH THE YWCA. THE CENTER IS ACCREDITED UNDER THE MISSOURI ACCREDITATION OF PROGRAMS FOR CHILDREN AND YOUTH. IT IS A MEMBER OF UNITED 4 CHILDREN, WHICH PROVIDES TECHNICAL SUPPORT AND IN-SERVICE TRAINING. HEALTH SCREENINGS ARE DONE THROUGHOUT THE YEAR. CHILDREN ARE EVALUATED REGULARLY FOR EDUCATIONAL DEVELOPMENT USING DIAL 4 AND DENVER

THE AFTER SCHOOL PROGRAM SERVES 54 CHILDREN AGES 6 TO 14 YEARS.
