KINGDOM HOUSE EARLY CHILDHOOD CENTER PROVIDES HIGH QUALITY CHILDCARE AND PRESCHOOL EDUCATION FOR NEARLY 100 CHILDREN, AGES 6 WEEKS TO 5 YEARS. THE CENTER IS OPEN YEAR-ROUND. THE CENTER PRIMARILY BENEFITS LOW-INCOME FAMILIES WHO NEED CHILDCARE BECAUSE THEY ARE EMPLOYED, IN SCHOOL OR IN TRAINING. SOME FAMILIES PAY THE FEE FOR SERVICE THROUGH THEIR CHILDCARE SUBSIDIES, WHILE OTHERS PAY ACCORDING TO A SLIDING SCALE FEE STRUCTURE. THE CENTER IS A HEAD START AND EARLY HEAD START PROGRAM PROVIDER THROUGH THE YWCA. THE CENTER IS ACCREDITED UNDER THE MISSOURI ACCREDITATION OF PROGRAMS FOR CHILDREN AND YOUTH. IT IS A MEMBER OF UNITED 4 CHILDREN, WHICH PROVIDES TECHNICAL SUPPORT AND IN-SERVICE TRAINING. HEALTH SCREENINGS ARE DONE THROUGHOUT THE YEAR. CHILDREN ARE EVALUATED REGULARLY FOR EDUCATIONAL DEVELOPMENT USING DIAL

KINGDOM HOUSE YOUTH PROGRAMS INCLUDE AN AFTER SCHOOL PROGRAM, 6-WEEK LITERACY-FOCUSED SUMMER CAMP AND KINGDOM ACADEMY, A PROGRAM TO HELP TEENS GRADUATE FROM HIGH SCHOOL AND GET INTO COLLEGE OR VOCATION. THE AFTER SCHOOL PROGRAM SERVES APPROXIMATELY 50 CHILDREN AGES 6 TO 14 YEARS. IT PROVIDES A SAFE AND ACADEMICALLY FOCUSED ENVIRONMENT CONDUCIVE TO HOMEWORK HELP AND SUPPLEMENTAL EDUCATIONAL CURRICULUM AND ACTIVITIES, SUCH AS FIELD TRIPS. KINGDOM HOUSE IS AN OFFICIAL CHILDREN'S DEFENSE FUND FREEDOM SCHOOLS PROGRAM PARTNER. NEARLY 100 CHILDREN AGES 6 TO 15 YEARS ARE SERVED THROUGH THE FREEDOM SCHOOL CAMP. BY PROVIDING SUMMER READING ENRICHMENT FOR CHILDREN WHO MIGHT NOT OTHERWISE HAVE ACCESS TO BOOKS, THE PROGRAM PLAYS A MUCH NEEDED ROLE IN HELPING TO CURB SUMMER LEARNING LOSS AND CLOSE ACHIEVEMENT GAPS.

ABOUT 1,400 INDIVIDUALS ARE SERVED YEARLY. 60% OF THOSE SERVED ARE LATINO AND SPEAK SPANISH AS THEIR PRIMARY LANGUAGE. MANY PARTICIPANTS HAVE CHILDREN THAT ENGAGE IN YOUTH PROGRAMS AT KINGDOM HOUSE.
